NOTIFICATION

No.SOR-III(S&GAD)1-2/2002(PI). In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the Punjab Agriculture Department (On-Farm Water Management Recruitment) Rules, 2003, the following further amendments shall be made:

AMENDMENTS

In the Punjab Agriculture Department (On-Farm Water Management Recruitment) Rules, 2003, in the Schedule:

- (1) at Sr. No.3, in column 7, for the existing entries, the following shall be substituted:
"By posting from amongst the Deputy Directors Agriculture (OFWM) (BS-18+SP) serving in the functional unit.";
- (2) at Sr. No. 4:
 - (a) for the existing entry in column 3, the following shall be substituted:
"Deputy Director Agriculture (OFWM) (BS-18+SP).";
 - (b) for the existing entry in column 7, the following shall be substituted:
 - (i) 25% by initial recruitment; and
 - (ii) 75% by promotion on the basis of seniority-cum-fitness at the ratio of 3:1 from amongst the Assistant Directors Agriculture (OFWM) / Assistant Directors (Tech.) / Assistant Agronomists and Assistant Agricultural Engineers / Publicity Officers with five years' service in the functional unit and having the requisite qualification.";
- (3) at Sr. No. 5:
 - (a) for the existing entry in column 5, the following shall be substituted:
"Ph.D. in Agricultural Engineering or M.Sc. Agricultural Engineering from a University recognized by Higher Education Commission with five years' experience in the line.";
 - (b) for the existing entry in column 7, the following shall be substituted:
"By initial recruitment.";
- (4) at Sr. Nos. 6, 7, 8, 12 and 13, in column 7, for the existing entries, the following shall be substituted:
"By initial recruitment."; and
- (5) at Sr. No. 9, in column 7, for the existing entries, the following shall be substituted:
"By posting from amongst the Deputy Directors Agriculture (OFWM) (BS-18+SP) serving in the functional unit.".
