No.SOR-III(S&GAD)1-2/2002(P). In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the Punjab Agriculture Department (On Farm Water Management) Recruitment Rules, 2003, the following amendments shall be made:

AMENDMENTS

"i) M.Sc. (Hons) Agriculture (second division) with Agronomy as a major subject from a recognized University; and

ii) five years' experience in the field of water management."; and

(iii) in column Nos. 8 and 9, for the existing entries, the following shall be substituted:

(d) at Sr. No. 17:

(i) in column No. 3, for the existing entry, the following shall be substituted:

"17. Assistant Director (Technical) (BS-18)";

(ii) in column No. 7, for the existing entry, the following shall be substituted:

"i) B.Sc. Agriculture Engineering (second division) from a recognized University; and

ii) five years' experience in the field of water management."; and

(iii) in column Nos. 8 and 9, for the existing entries, the following shall be substituted:

"26"	"35"

(e) at Sr. No. 22, in column No. 7, for the existing entry, the following shall be substituted:

"22. ..."

- (i) 20% by promotion on seniority-cum-fitness basis from amongst Water Management Supervisors having five years' service as such; and if none is available for promotion, then by initial recruitment.
- (ii) 10% by selection on merit from amongst Water Management Supervisors having qualification of B.Sc. (Agriculture) Engineering or B.Sc. (Civil / Mechanical) Engineering or B.Tech (Hons) from a recognized University and at least two years' experience in the functional unit."; and
- (f) at Sr. No. 37, in column No.7, for the existing entry, the following shall be substituted:  
"By promotion on seniority-cum-fitness basis from amongst Tracers (BS-5) with at least five years' experience in the functional unit; and if none is available for promotion, then by initial recruitment."


