


INVITATION FOR BIDS **For Procurement of Tractors**

The Directorate General Agriculture (Extension), Punjab, Lahore invites sealed bids through e-Punjab Acquisition & Disposal System (EPADS) from local Tractor Manufacturers having valid NTN/STRN, Punjab Sales Tax Registration (where applicable), and placed on the Active Taxpayers List (ATL) of FBR and have a valid manufacturing license issued by the Engineering Development Board (EDB) of Pakistan for "Procurement of Tractors under Wheat Incentive Program 2025-26", as per the following details, which shall conform to the technical specifications and Schedule of Requirements mentioned in the Bidding Documents: -

3. **Single Stage – Two Envelope** bidding procedure shall apply as specified in the Punjab Procurement Rules, 2014 (as amended to date). Bids, duly accompanied by a scanned copy of **Bid Security @ 5%** of the estimated cost as mention above for each item in the shape of Bank Draft/Call Deposit/Demand Draft/Banker's Cheque in favour of Director General Agriculture (Extension), Lahore, shall be uploaded on e-Punjab Acquisition & Disposal System (EPADS) on or before **18th May, 2026 at 1000 hours**. The original Bid Security in a sealed envelope must be delivered to the address given below on or before the closing date/time i.e. **18th May, 2026 at 1000 hours**. Late bids shall not be accepted. Bids shall be publicly opened through E-PADS at **1030 hours** on the same date.
4. A bidder may bid for one or more items, Evaluation and comparison of bids for each Item / Tractor shall be carried out separately. Partial, conditional or incomplete bids shall not be accepted. The bidders are requested to give their best and final prices inclusive of all applicable taxes, freight etc. as no negotiations on the prices are allowed. The Agriculture Department may reject all bids at any time prior to the acceptance of a bid by invoking rule 35 of Punjab Procurement Rules, 2014.
