

INVITATION FOR BIDS

PROCUREMENT OF HI-ROOF VAN 2750CC

The Chief Scientist, Agricultural Biotechnology Research Institute, Ayub Agricultural Research Institute, Jhang Road, Faisalabad invites sealed bids through e-Punjab Acquisition & Disposal System (EPADS) from interested bidders having valid NTN/STRN, Punjab Sales Tax Registration (where applicable), and placed on the Active Taxpayers List (ATL) of FBR, for “Procurement of Hi-Roof Van 2750 CC,” under the ADP Project “Revamping of Agricultural Research in Punjab” as per the following details, which shall conform to the technical specifications and Schedule of Requirements mentioned in the Bidding Documents: -

3. **Single Stage – Two Envelope** bidding procedure shall apply as specified in the Punjab Procurement Rules, 2014 (as amended to date). Bids, duly accompanied by a scanned copy of **Bid Security @ 3%** of the estimated cost in the shape of Bank Draft/Call Deposit/Demand Draft/Banker’s Cheque in favour of Chief Scientist, Agricultural Biotechnology Research Institute, Ayub Agricultural Research Institute, Jhang Road, Faisalabad, shall be uploaded on e-Punjab Acquisition & Disposal System (EPADS) on or before **16th March, 2026 at 1100 hours**. The original Bid Security in a sealed envelope must be delivered to the address given below on or before the closing date/time i.e. **16th March, 2026 at 1100 hours**. Late bids shall not be accepted. Bids shall be publicly opened through E-PADS at **1130 hours** on the same day at the address given below.

4. Conditional or incomplete bid will not be accepted. Evaluation and comparison of bids for each item shall be carried out separately. The bidders are requested to give their best and final prices inclusive of all applicable taxes, freight etc. as no negotiations on the prices are allowed. The Agriculture Department may reject all bids at any time prior to the acceptance of a bid by invoking rule 35 of Punjab Procurement Rules, 2014.
