NO. SO (R&E) 23-22/2022-VC-RWP: In term of Section 14 (2) of the Pir Mehr Ali Shah Arid Agriculture University, Rawalpindi Act, 1995, Government of the Punjab, has been pleased to approve the following eligibility criteria/qualifications, experience and other relevant requirements for the post of Vice Chancellor, Pir Mehr Ali Shah Arid Agriculture University, Rawalpindi:-

- i. Ph.D. in Agriculture or related academic discipline from a recognized University or equivalent qualification;
- ii. The candidate should have a minimum experience of 15 years in teaching, administrative, planning and financial matters;
- iii. The candidates should have to his credit a minimum of 5 quality research publications in HEC recognized journals;
- iv. These are leadership positions with main responsibility of promoting academic excellence, transparent governance and motivating the university faculty and administration to work together for achieving increasingly higher standards of teaching, learning and research;
- v. The position also requires rich experience in academic and financial management with proven track record of skills in initiating and managing change, strategic planning, overseeing implementation and the capability of mobilizing resources for the university and its research programme and networking with national and international institutions;
- vi. Other skills required include the ability to integrate the results of agricultural research into agricultural education and to spread the benefits of both to the farmers through a modern system of dissemination and extension.
- vii. The candidates obtaining 70% marks in accordance with the above mentioned criteria shall be called for interview.
- viii. A person who is eligible and who is not more than sixty five (65) years of age on the last date fixed for submission of applications for the post of Vice Chancellor may apply for the post.
- ix. The Chancellor shall appoint the Vice Chancellor for each term of four years but he shall serve during the pleasure of the Chancellor.

NOTIFICATION

NO. SO (R&E) 24-1/2017-VCs: In term of Section 14 (4) of the Pir Mehr Ali Shah Arid Agri. University, Rawalpindi Act, 1995, Government of the Punjab has been pleased to approve following Guidelines / procedure and criteria for short listing of candidates and selection of panels to be followed by the Search Committee for appointment of Vice Chancellor, Pir Mehr Ali Shah Arid Agriculture University, Rawalpindi:-

GUIDELINES

- i. Preparation of proforma and formula for short listing of candidates in accordance with approved quantifiable criteria of the Government.
- ii. Short listing of candidates in accordance with prescribed proforma and formula.
- iii. Conduct interviews of the short listed candidates in accordance with the criteria notified by the Government for the interviews.
- iv. Search Committee shall ensure that adequate time is given to each candidate appearing for the interview and each candidate is treated fairly without any bias or discrimination.
- v. After conducting interview of each candidate, the Convener shall invite opinion of each member. The Convener shall take average of all members' score which is then assigned to each candidate on the basis of performance in the interview.
- vi. In case of any difference of opinion, the Convener shall ask each member to explain their view point and efforts will be made to arrive at a consensus. In rare cases where consensus is not possible, majority view point shall be considered for final allocation of interview score.
- vii. Search Committee shall recommend to the Government, in alphabetical order, a panel of three persons who, in its opinion, are suitable for appointment as Vice Chancellor.
- viii. Each member of Search Committee will disclose before the start of interviews that he / she has no conflict of interest in assessing any candidate.
- ix. Search Committee shall maintain a strict level of confidentiality to protect the privacy of the candidates and to preserve the integrity of the search process.


