The Government of Punjab, through the Directorate General Agriculture (Extension), Agriculture Department, intends to launch the "Productivity Enhancement of Cotton in Bahawalpur" Scheme to improve cotton productivity through provision of subsidies for Shoulder Mounted Generator Operated Power Sprayer (SMG Power Sprayer) and Chisel Ploughs.

- The Director General Agriculture (Extension) Invites Expressions of Interest (EOIs) from interested importers, firms / companies of SMO Power Sprayers and manufacturers, firms / companies of Chisel Ploughs for pre-qualification. The prequalified manufacturers, importers, firms / and companies will work with the Punjab Agriculture Department for the provision of SMO Power sprayer and Chisel Plough to the selected farmers across Bahawalpur Division, Punjab Province.
- Firms / companies must be on the Active Taxpayers List (ATL) of the Federal Board of Revenue (FBR). The Importers, firms / companies of SMG Power Sprayers must possess a valid Sole Proprietorship Certificate issued by the Principal Manufacturer or dealership authorization certificate from the Original Equipment Manufacturer (OEM) and the Manufacturers Firms and Companies of Chisel Plough must have minimum 3-year experience in relevant field.
- Expression of Interest documents, (containing detailed requirements and modalities etc.) can be obtained on payment of PKR 500/- (non-refundable) from the office of Director General Agriculture (Extension) Punjab, 21-Davis Road, Lahore, Ph # 042-99200732.
- The Agriculture Department reserves the right to accept or reject any or all EOIs without assigning any reason. This invitation for EOI does not constitute a commitment or obligation on the part of the Department to award any contract or financing arrangement. Only prequalified firms will be eligible to participate in the next stage of the scheme.
- The expression of interest, prepared in accordance with the instructions in the EOI documents, must reach at office of Director General Agriculture (Extension) Punjab, 21-Davis Road, Lahore on or before 11:00AM on 25-02-2026. The EOIs will be opened on the same day at 11:30 A.M.
