

SO (R&E) 3-10/2019-Ph.D: The cases for nomination of departmental candidates for admission in Ph.D. studies in the relevant fields, against reserved seats at Agricultural Universities, working under the administrative control of Agriculture Department will be decided, in future, inter alia, in accordance with the framework prescribed hereunder:

Basic Eligibility Conditions

- i. M.Sc. (Hons) / M. Phil with minimum CGPA 3.00 (only those candidates will be considered who have qualified the GRE or equivalent test of the concerned University obtaining minimum of 70% marks).
- ii. Maximum age limit : 42 years.
- iii. Regular employee of Agriculture Department.
- iv. Minimum five (05) years service in Agriculture Department including regular and contract period.

Criteria for Nominations

Nominations amongst candidates meeting basic eligibility conditions will be made on merit strictly as per following criteria:

Other Conditions

- i. Certificate from Head of Attached Department that no departmental/anti-corruption enquiry is pending against the applicant.
 - ii. Surety Bond to the effect that after completion of Ph.D / expiry of study leave, the nominee shall serve Agriculture Department / Universities under administrative control of Agriculture Department for a minimum period of 05 years, failing which he/she will pay Rs. 1.500 million or the salary received during the period of study leave, whichever is higher.
 - iii. The selected candidates will be granted study leave, subject to satisfactory performance, on year to year basis in accordance with applicable Study Leave Rules.
 - iv. After nomination and completion of admission process, if the officer fails to join Ph.D. course for any reason, disciplinary action under rules may be taken against him/her.
2. The eligibility criteria notified for nomination of departmental candidates for Ph.D. study at Agricultural Universities in the Punjab vide this department's Notification No. SO (R&E) 3-10/2014 dated 03.08.2016, is hereby repealed.
