1. You are hereby invited to submit bids as per Rule 38(2) of PPRA Rules, 2014 amended up to 31.12.2021. Single Stage – Two Envelope Bidding Procedure shall be followed under Open Competitive Bidding, containing separately the financial proposal and technical proposal for the store as detailed in the schedule to this invitation to tender subject to the conditions laid down in bidding documents. The contract resulting from this invitation to tender shall be governed by the conditions as contained in bidding documents. The bid quoting against this invitation shall be deemed to have read and understood the conditions thereof and particulars of the stores required and their specifications, etc.
2. The bidding document containing specifications and detailed terms and conditions are immediately available and can be obtained from Store Keeper of this Directorate General on any working day from 9.00 to 17.00 hrs. against non-refundable cash payment of Rs. 1000/- for each tender/ bidding document within due date. The same can also be browsed from Agriculture Department website www.agripunjab.gov.pk and PPRA Website- ppra.punjab.gov.pk.
3. The bidder shall quote their firm and final rates as there shall be no negotiation.
4. The bidder shall quote on the prescribed schedule to this invitation to tender, on the basis indicated therein and shall sign the certificate to the effect that the stores shall be supplied in accordance with the requirement specified in the schedule. In case there is any deviation, it should be clearly stated by bidder otherwise it will be presumed that offer is strictly in accordance with the requirement of the bid notice.
5. In the case of offers for supply of stores both imported and indigenous from within the country price quoted shall be inclusive of all taxes, duties and charges for packing, making, handling etc, where sales tax is leviable and is included in the price quoted it shall be indicated separately.
6. The procuring agency may reject all bids or proposals at any time prior to the acceptance of bids of proposal (Rule 35).
7. Failure to submit the bid in the manner prescribed in the invitation to tender will render it liable to be ignored.
8. The purchaser does not pledge himself to accept the lowest bid and reserves to himself the right of accepting the full or part quantity offered and the bidder shall supply the same at the rate quoted.
