

REQUEST FOR EXPRESSIONS OF INTEREST (REOI)

FOR HIRING OF CONSULTING SERVICES

UNDER "CHIEF MINISTER'S PROGRAM FOR WATER EFFICIENT" PROJECT

The Agriculture Department, Government of the Punjab, has received financing from the Punjab Government toward the cost of the "Chief Minister Program for Water Efficient" project and intends to apply part of the proceeds for consulting services. The key objective of the proposed project is "to improve the conveyance viz-a-viz application efficiency".

The project intends to hire supervision & third-party validation consultant. The consulting services ("the Services") are required to provide supervision & third-party validation support for validation of project activities. The objective of the assignment is to engage an engineering consultancy firm to provide support for the review and approval of designs & cost estimates, construction supervision, quality assurance, quantity certification, technical assistance, and overall coordination of project execution. The gestation period for consulting services will be 36 months starting as early as possible.

1. Directorate General Agriculture (Water Management) Punjab, Lahore now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultancy firms are required to provide information demonstrating that they have the requisite qualifications and relevant experience to perform the Services.

Expression of Interest (EOI) is invited from eligible Firms/ Companies with appropriate in-house expertise through E-PADS under the project titled "Chief Minister Program for Water Efficient Agriculture". Applicant Firms/ Companies are requested to provide only relevant and complete information specific to the proposed assignment and avoid submitting generic promotional literature.
3. Interested Firms / Companies registered on E-PADS meeting the mentioned criteria in PQD as a prerequisite may download from websites <https://ofwm-agripunjab.punjab.gov.pk/>, www.ppra.punjab.gov.pk and E-PADS portal <https://punjab.eprocure.gov.pk/#/auth/login> downloaded free of cost.
4. The Expression of Interest, prepared in accordance with instruction in the PQD, must be submitted through E-Procurement (E-PADS) on or before 30.09.2025 at 11:00 AM. EOIs received later than the specified time and date shall not be entertained for any reasons whatsoever.
5. The EOIs will be publicly opened in Committee Room of "Directorate General Agriculture (WM) Punjab, Lahore, 21 Davis Road Lahore. on same date at 11:30 AM online through the E-PADS system.
6. Any misinformation, false and forged statements will lead to disqualification from hiring process and any other action as per applicable laws. The department reserves the right to withdraw this EOI at any time and interested Firms/ Companies are responsible for all costs incurred arising from or in relation to this request.
